

# Imperial Holdings Announces Name Change to Emergent Capital

**New NYSE Ticker Symbol, "EMG," to be Effective September 1, 2015**

(NYSE: IFT) has changed its corporate name to Emergent Capital, Inc. and will begin trading on the New York Stock Exchange under the ticker symbol "EMG" at the start of trading Tuesday, September 1, 2015. Shareholders approved the name change at the annual meeting of shareholders on May 28, 2015.
