Leclanché announces extension of the publication deadline for the 2023 interim results

YVERDON-LES-BAINS, Switzerland, October 2, 2023 – In its decision of September 29, 2023, SIX Exchange Regulation AG approved an extension of the publication deadline of Leclanché's (SIX: LECN) 2023 semi-annual report until October 31, 2023.

The Company has requested an extension of the deadline for releasing its 2023 semi-annual report due to various illness-related absences in the finance team, which have delayed the consolidation work for semi-annual report. These unforeseen events have taken place in addition to changes in the Company's accounting team, during the past months.

In its decision of September 29, 2023, SIX Exchange Regulation AG requested Leclanché to insert the below excerpt in this ad hoc announcement:

The exemption request of Leclanché (Issuer) dated 27 September 2023 regarding an extension of the deadline to publish its 2023 semi-annual report and to file such report with SIX Exchange Regulation AG until 31 October 2023 at the latest is granted with the following reservation (lit. a) and under the following conditions (lit. b):

a. SIX Exchange Regulation AG reserves the right to suspend trading of the registered shares of the Issuer in case its 2023 semi-annual report is not published in accordance with the provisions on ad hoc publicity (Art. 53 of the Listing Rules [LR] in connection with the Directive on Ad hoc Publicity [DAH]) and not filed with SIX Exchange Regulation AG until Tuesday, 31 October 2023, 11.59 pm CET, at the latest.

b. Leclanché is required to publish a notice in accordance with the provisions on ad hoc publicity (Art. 53 LR in connection with the DAH) concerning this decision until Monday, 02 October 2023, 7.30 am CET, at the latest. The notice must contain:

- the unaltered reproduction of the wording of para. I. of this decision, placed in a prominent position;
- the reasons for the application of the Issuer requesting an extension of the deadline to publish its 2023 semi-annual report and to file such report with SIX Exchange Regulation AG.
